




#### **SEHDAO-Kit with Standalone Electronic Locks**






#### SEHDAO-Kit used with side mount or undermount electronic locks

The SEHDAO accessory kit can be used with side mount and undermount electronic locks (38TREL, 38ELAO, and 3135TREL), refer to figure 3 for setback on inset or overlay applications.

The accessory kit can be installed on the side, under, or on top of the drawer, but the mechanism needs to be in contact with the back of the drawer front.
